- i. By signing this agreement I enter into it freely and voluntarily and agree that;
- ii. I have declared any medical conditions to the club and agree to do so in the event of further conditions arising.
- iii. I have registered personally as a player with BAFA and have a BAFA registration number. I have paid my BAFA registration fee for the 2019 season and am eligible under BAFA rules to play for Ouse Valley Eagles
- iv. I recognise that as of close of 31 January 2019 I am in debt to Ouse Valley Eagles to the value of the annual subscription option I have selected above.
- v. If my annual subscription is not fully settled by close of Sunday 30 June 2019 I shall be considered a debtor.
- vi. The use of club equipment, including game shirts, is discretionary. All club property must be returned upon demand. Any retention will be considered a debt and subject to the BAFA debtor policy.
- vii. Any debt to the team, whether financial or retention of club property including game jerseys, from this or from previous seasons must be settled or subject to an agreement which is satisfactory to the Club Treasurer in order to maintain playing eligibility. Failure to do so will result in the player being referred to the League Debtors List on 1 September 2019. This will result in the player being unable to play BAFA regulated American Football until this debt is cleared. Any transfer request to another team will be declined.
- viii. I am a representative of Ouse Valley Eagles and, as such, I will refrain from swearing or making rude gestures on the side-line on game days or when practising alongside Academy teams and will conduct myself in a responsible manner on and off the pitch.
- ix. I will be polite and respectful to the coaching staff of Ouse Valley Eagles and BAFA Officials at all times.
- x. I must not make any comments on any Social Networking medium (e.g. Forums, Twitter, Facebook, Instagram) that may bring the reputation of the club into disrepute or appear as club policy.
- xi. On the field, I will wear the correct kit, consisting of approved shoulder pads, white helmet with team decals and grey face-cage, white game pants with integral padding and mouth-guard. Game jerseys are supplied by the club and shall be returned at the end of each game. Any accessories such as under armour, gloves and socks not in team colours will not be allowed on the pitch during games. I understand that if I am not correctly attired it may result exclusion by officials or by team management until such time as the correct kit is worn.
- xii. I will attend all team practices and games. I will advise coaching staff at least one week in advance if I cannot.
